The Fort Lupton Fine Art Show will be held at the Fort Lupton Community Center. The center offers the venue to display artwork in a modern gallery setting.

RULES OF PARTICIPATION

ELIGIBILITY

- All jury artwork exhibited must be original in both concept and execution, and completed in the last 7 years.
- Entry fee is \$5.00, nonrefundable, for each individual entrie.
- This year we are allowing artist to set up an optional 8 x 10 booth.

BOOTH OPTION

- Artist can set up and display an unlimited amount of art within an 8 x 10 area. In addition artist can submit up to 4 original pieces of artwork to be included in the juried competition of the show.
 - \$25.00 if artist provides display panels
 - \$35.00 if recreation center provides panels
- This competition is open to all artists 16 yrs. and older.
- Reproduction prints are allowed as bin items only and is limited to up to 10 items for non booth entrants. There is no additional charge for bin items on accepted entrants.
- Juried entries shall be submitted as jpegs.

Honorable Mention Awards

SALES

All sales of artwork will be conducted by Fort Lupton Recreation Center Cultural Event Programs organizers. A 10% commission will be retained by Fort Lupton Recreation Center Cultural Event Programs on all artwork sold during the exhibition.

JUDGING

All entries will be juried by jpeg entries. Entrants will be notified of jury results by mail. Accepted artwork (may be used for publicity purposes). Awards will be chosen by the juror after artworks have been received. During final jury process any artwork found to contain unacceptable material or is not identical to the jpeg submitted, will not be judged for awards or exhibited and will be returned to the artist. Accepted art must be appropriate for general public venues.

FRAMING AND MOUNTING

All wall hanging art must be properly framed and wired, ready to hang. (no sawtooth or "clipped in" hangers). A "Gallery Wrapped" canvas (a canvas that wraps completely around to the back of stretchers & stapled or tacked on back with no exposed staples or tacks on side edges) will be accepted without a frame only if it is properly wired for hanging and all "Gallery Wrapped" edges are painted (finished). Any "Gallery Wrapped" canvas with exposed unpainted canvas on edges will be rejected. A standard canvas (with staples/tacks on side edges) must be framed. All sculptures and other 3-dimensional work must be properly mounted and ready for display. No artwork may weigh more than 100 pounds. If upon arrival the artwork weighs more than 100 pounds it will be rejected. All artwork must be labeled with title, artist's name, media and price on the back (or bottom for sculptures).

Hanging piece that cannot be hung on standard (1 or 2) picture hangers, are not acceptable. No screws, molly bolts, lag bolts, or other anchors will be allowed. No three dimensional pieces will be attached to floor or suspended from ceiling.

SHIPPING & DELIVERY OF ACCEPTED WORKS

- Shipped artwork must be received by 5:00 p.m. September 7, 2011, and should be shipped to City of Fort Lupton, C/O K. Cade 130 S. McKinley Ave. Fort Lupton, CO 80621, with a Prepaid Federal Express or Prepaid UPS return shipping label. Artwork must be shipped in strong, reusable cartons or crates with no free-floating styro-foam popcorn packing.
- Hand delivered artwork will be accepted on Thursday, September 8, 2011, between 3:00 p.m. and 7:00 p.m. at the Fort Lupton Recreation Center, 203 S. Harrison, Fort Lupton, CO.

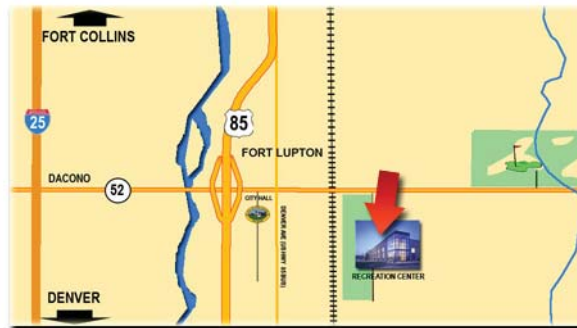
RETURN OF WORK

- Shipped artwork will be returned by the Cultural Event Programs committee members to the artist following the closing date of the exhibition in accordance with prepaid labels.
- All hand delivered artwork must be picked up on the show's closing date, Sept. 10, 2011 between 4:00 p.m. and 5:00 p.m. **No early pick-ups are allowed.**

ADDITIONAL INFORMATION

- The Cultural Event Programs committee members will exercise professional care in handling all entries, but will not assume liability for loss or damage while in the organization possession or in transit. It is suggested that artists wishing additional protection insure their works independently.
- A reception will be hosted by the Cultural Event Programs committee members Friday evening, from 6:00 to 7:00 p.m. Participating Artists and the public are invited.

CATEGORY DESCRIPTIONS

FINE ART: Paintings, drawings, mix media, metal work hung on walls, fiberart that is framed (no quilts or craft creations will be accepted).

PHOTOGRAPHY: traditional and digital mediums, accepted.

THREE DIMENSIONAL ART: Bronze, Glass, Ceramic, Stone, Wood, and other material that creates a 3 dimensional art form. Jewelry will only be accepted if it is of original creation using raw material (no bead or craft type product will be accepted).

DIGITAL ENTRIES

Digital entries can be emailed directly to kcade@fortlupton.org or shipped via CD to Fort Lupton Recreation Center, Fine Art Show, 203 S. Harrison, Fort Lupton, CO 80621. Files must have these characteristics:

- Files must be named <firstinitial><lastname><category><entry#>.jpg <K><CADE><FINEART><01>.jpg (e.g.,KCADEFINEART01.jpg)
- Files must be saved as JPEG, 300 dpi resolution.
- JPEGs must be no larger than 1024 X 768 pixels on the long edge and no larger than 1Mb in file size.
- Please do not include #,\$,%, periods or other similar characters as part of the file name.
